ORDER

The Reservation for Economically Weaker Sections (EWS) in Government Pharmacy/Para Medical Degree institutions in the State of Kerala was implemented vide Government order read as first paper above. The Prospectus for Admission to Para Medical Degree Courses for the Academic year 2020-21 has already been approved by the Government and the provision for EWS Reservation had not been included in the said Prospectus.

Vide letter read as second paper above, the Director of Medical Education has forwarded the seat details including the number of seats proposed to be increased for implementing EWS reservation, for Government approval and has requested to direct CEE and LBS to issue necessary directions to the candidates and to make necessary modification in the software application during admission process accordingly.

3) Government have examined the proposal in detail and are pleased to accord sanction to increase seats to implement EWS Reservation in Pharmacy/Para Medical Degree Courses, as detailed below, from the academic year 2020-21, without any additional financial commitment involved, subject to affiliation by Kerala University of Health Sciences/Pharmacy Council of India. The Director of Medical Education shall obtain affiliation of Kerala University of Health Sciences/Pharmacy Council of India for seat enhancement.
